Our Guarantee

I. BUYER AGREES:

1. To have the puppy examined within 72 hours of purchase by a licensed veterinarian to validate this guarantee. If the puppy is returned due to illness, a letter from the veterinarian is required.
2. That this puppy is being sold as a pet and companion animal. The Buyer acknowledges that the application for registration of this puppy is limited as defined by the American Kennel Club (AKC) and this puppy is not being sold for the purposes of breeding. Limited Registration means that the dog is registered with the AKC, but no litters may be produced by said dog and if a litter is produced, it will not be eligible for registration. If said dog has been bred, this contract is void.
2. The Buyer agrees that he/she will not sell, transfer ownership or possession of the puppy to any person or organization whose intent it is to resell (such as a pet store), trade, or give away the dog, or use it in any experiments, laboratory or otherwise or to use it as breeding stock for a puppy mill. Buyer also agrees this dog will never be surrendered to any humane society, animal rescue group or animal shelter. L'Abri Ranch English Golden Retrievers will accept this dog that is unable to be cared for and shall assume ownership of, possession of, and responsibility for any such animal previously purchased from L'Abri Ranch English Golden Retrievers.

3. To provide annual vet exams, to continue all required vaccines and annual boosters, regular de-worming as recommended by their vet and follow all recommendations of vet in regard to proper care. Failure to comply with and provide documentation of these requirements voids all guarantees.
4. Buyer agrees to provide adequate housing away from the elements. The dog must mainly reside in the house and a fenced yard or kennel and adequate shade are required. Dog will NEVER be left on a chain or rope. The Buyer will groom, train, and care for this dog in the manner consistent with high quality animal husbandry.
5. We believe that the Life's Abundance Food and Products provide the optimum nutritional benefits to best ensure good health and longevity for our puppies and dogs. We so strongly believe that optimum nutrition plays an integral role in the short and long-term health of our dogs and puppies, that we are offering an optional 1 (one) year extension to our health guarantee if the following provisions are adhered to:
 - The puppy identified above must be fed Life's Abundance System, which includes the Life's Abundance food for the first 24 months of life.
 - The owner of this puppy, recorded above, must order Life's Abundance Food at www.lifesabundance.com/labriranch or call LA Customer Service at 1-877-387-4564, and order under Independent Representative L'Abri Ranch English Golden Retrievers, Rep #20715233 for tracking purposes.
 - **At any time within your puppy's first 24 months, should your puppy be removed from the Life's Abundance food, the additional 1 (one) year extension of the health guarantee becomes void without exceptions.**
6. The value of the pet for the purpose of this guarantee is solely the original purchase price of the pet, and does not include any additional prices declared by the buyer, such as value of show dog or shipping fees.
7. To keep puppy/dog in good physical condition and proper weight.
8. To have puppy spay/neutered at age recommended by vet but before one year of age.

The following will void all guarantees in the discretion of the breeder:

1. Buyer permitting the dog to be underfed or overfed at any time. Underfed: Ribs are highly visible Ideal Body Condition: Can feel outline of ribs. Dog has a waist when viewed from above. Belly is tucked when viewed from the side. Overfed: Dog has no waist when viewed from above. Belly is rounded when viewed from the side. (Please take into consideration how thick a coat your dog has when viewing).

2. Evidence of neglect or abuse.
3. Previous related trauma (broken bones, related injuries, etc.)
4. Dog has been bred.
5. Feeding this dog anything other than a premium quality dog food.
6. Feeding a dog food that is not a recommended 4 or 5 star brand.

II. BREEDER AGREES:

1. Breeder guarantees that the puppy has had proper care to date and has been checked by a veterinarian. Puppy has received its first shots and been wormed at the proper times. Records will be furnished at the time of purchase. If the puppy is being shipped such records will be with the puppy. If within 72 hours of receiving the puppy and he/she is examined by a licensed veterinarian and the health of the puppy is found to be at risk due to a congenital defect, owner shall notify breeder and provide a written statement from a licensed vet describing puppy's condition and shall return the puppy and papers to the breeder within three days of the examination. Breeder will replace the puppy or refund money provided the puppy is in the same condition mentally and physically as when originally purchased.
2. Breeder is not responsible if the puppy contracts a communicable disease after leaving the breeder's possession.
3. Breeder offers a two year hip guarantee on any puppy found to have moderate or severely affected hip dysplasia that adversely affects the quality of life as a family pet. The puppy must have veterinarian confirmation and official OFA preliminary consultation. Vet confirmation must state that he/she feels that the condition is congenital and not the result of an injury or abuse including over exertion. If hip dysplasia is suspected, the Buyer will obtain x-rays. All veterinarian documents and x-rays must be submitted to the Breeder. If the claim occurred within the first two years and is valid, the Seller will replace the pup with a pup of equal value, the same gender, and the same breed, as pups are available, with the Buyer being responsible for all transportation costs. If the dog being replaced is used for breeding during, prior or after, the claim will be void. If genetic eye disease is suspected, a CERF examination must be done by the time the dog reaches 1 year of age by a licensed canine ophthalmologist.
4. The Breeder will not pay any veterinary costs incurred for either of these tests, x-rays, office visits or any treatments; only replace the dog with a puppy from a future litter. Breeder reserves the right to have a second opinion from a personal vet and obtain DNA to determine the dog or puppy is of T.E.R. lineage.
5. In the case of sudden demise of puppy, breeder must receive a written notice of puppy's death from owner's vet, along with a necropsy report stating cause of death.
6. Breeder does not guarantee color, size, championship or temperament of any puppy.
7. To be covered by this guarantee, the puppy must be owned by original owner named in this agreement.
8. Breeder does not guarantee against non-threatening puppy problems i.e. parasites, hernias, missing or misaligned teeth, infertility, allergies. Breeder does not guarantee against avoidable disease caused by improper care or neglect by the Buyer. The puppy is healthy at the time of sale. The puppy has had the immunization provided in the health record. Vaccinations must be kept current or the guarantee is void regarding said puppy.
